A registered agent in Ohio provides a legal address where someone is present during typical business hours. Your registered agent is accountable to accept delivery of service of process and legal documents on behalf of your business and then forward this paperwork on to your business.

REGISTERED AGENT OFFICE IN OHIO

According to Ohio law, almost every entity doing business in Ohio must maintain a statutory agent (registered agent) and registered office. What Ohio Registered Agents Do: The registered agent accepts service of process, notices and official mail that is served on the business entity at the registered office.

Ohio Registered Agents

A Registered Agent in Ohio is a person or company who agrees to accept legal mail on behalf of your LLC in case your business gets sued. In Ohio, they use the word "Statutory Agent" instead of Registered Agent, but we refer to it as Registered Agent below as it's a more commonly used term. Please note that they both mean the same thing.

Ohio Registered Agent Info

In Ohio, a registered agent is more commonly referred to as a statutory agent. When you use Northwest as your Ohio registered agent service, all the forms and filing instructions are available instantly, pre-signed for your convenience. You will still always have to sign the filings yourself.

Ohio Statutory agent: To resign, the Ohio registered agent must send a copy of the Statutory Agent Update

Form to the company they had been representing. Then, the agent must submit the Statutory Agent Update Form with \$25 for processing to the Ohio Secretary of State online, by mail or in-person.

How to resign as statutory agent for Ohio LLC or corporation

Generally, the registered agent is also the person to whom the state government sends all official documents required each year for tax and legal purposes, such as franchise tax notices and annual report forms. It is the registered agent's job to forward these suit documents and notices to the entity itself.
